Legislative Changes

HB626 - HISTORIC HORSE RACING

On June 8, 2021, Governor Sununu signed HB626 into law.

This newly signed bill allows charitable games of chance operators to offer historic horse racing wagering at their licensed facilities.

LOT Rules of the Month

BINGO

Lot 7005.03(g)(8) - Card-minding devices shall be programmed to only allow bingo faces sold, loaded, and enabled during an open bingo session, to be in play during that open session.

LUCKY 7

Lot 7104.04(m)(4) - Develop a procedure to record the gross receipts generated from the sale of lucky 7 tickets sold, and implement such procedures through such things as an inventory accounting system or a floor worker sales report.

GAMES OF CHANCE

Lot 7203.05(c) - Each individual applying for a secondary game operator license shall submit documents to the commission at least 60 days prior to the expiration of the applicant's current license or participating in the operation of games of chance, if not currently licensed.

Bingo & Lucky 7

Completing Applications

When filling out any bingo and lucky 7 applications and forms, please keep this information in mind:

- All applications must be complete and accurate. Be sure to provide a response to all questions within the application, do not leave any fields blank.
- The contact information provided on the application MUST reflect the true contact information for the entity/individual requested. Do not use the charitable organizations phone, email or address information for individual members such as the treasurer, president, etc.
- All applications must be signed by an authorized official of the charitable organization. This individual MUST be a bona fide member of the organization and have

full authority to submit official documents on the charity's behalf.

- Future applications, renewals and financial reports must be submitted using the correct forms. Any paperwork submitted on old forms may be returned and could possibly result in your organization missing important deadlines.

Games of Chance

SB23 - Member Affidavits

SB23 was signed into law and will be effective on August 30, 2021. This bill repeals the requirement that a member of the charity be present during the event and sign an affidavit. Charitable organizations will need to continue signing the member affidavit forms until August 30, 2021

SB25 - Charitable Organization's License Periods

SB25 was signed into law and is effective as of July 1, 2021. This bill changes the games of chance licensed period for charitable organization's back to a calendar year (Jan-Dec). Due to this change, any charitable organization's that were licensed in calendar year 2021 will automatically expire December 31, 2021.

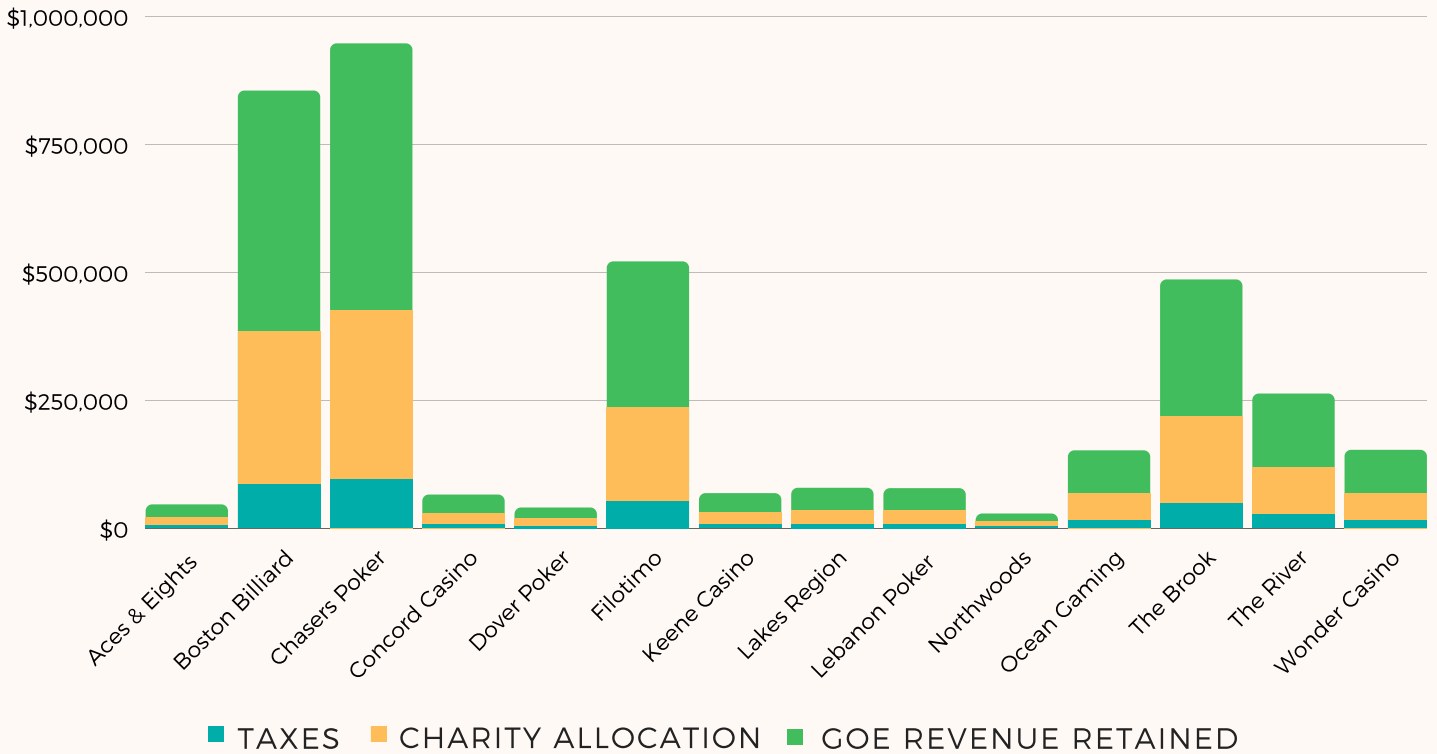
