Reminder of Application Submittal Deadlines

- Charitable Organization Application - 60 days prior to the first proposed game date
- Secondary Game Operator Application - 60 days prior to the expiration of the applicant's current license
- Primary Game Operator Application - 60 days prior to the expiration of the applicant's current license
- Facility License Application - 120 days prior to the expiration of the current license
- Game Operator Employer Application - 120 days prior to the expiration of the applicant's current license

Failure to submit applications within these time frames can result in a delay of the license being issued.

FBI Criminal Background Check Fees

Effective January 1, 2019 the fee for an FBI Criminal Background Check has increased to \$48.25. Any old fees received after January 1, 2019 will be rejected and returned requesting new payment. Please make all checks payable to "STATE OF NH-CRIMINAL RECORDS" for the total amount due. We also have updated the criminal background form to reflect the increased fee. 
