JANUARY

BINGO LOT RULE OF THE MONTH:

Lot 7003.02(f) – The charitable organization shall submit a license application and related documentation to the commission at least 15 days, but no more than 45 days prior to the first bingo event of the month or year for which the license has been requested.

LUCKY 7 LOT RULE OF THE MONTH:

Lot 7103.03(d) – A gaming consultant shall not be a licensed distributor or manufacturer, be employed by a distributor or manufacturer, or have any direct or indirect financial relationship with a distributor or manufacturer.

GAMES OF CHANCE LOT RULE OF THE MONTH:

Lot 7203.01(b)(2) – To be eligible for a license, a charitable organization must be registered with the secretary of state as a domestic non-profit authorized to do business in NH for 2 or more years prior to the application.

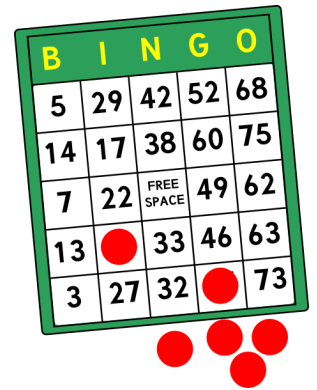

2021 BINGO & LUCKY 7 LICENSES

It's time to renew Bingo and Lucky 7 (L7) licenses for 2021!

Copies of our new applications and other documents pertaining to Bingo/L7 can be found on our website. Please note, each of the following documents

MUST be submitted with the first application for 2021 game dates (i.e. your January Bingo/L7 applications). Failure to submit all required documents and payments will delay the processing of your application. Supporting documents to be included with your January applications are:

- Documentation confirming the organization's federal tax-exempt status;
- Documentation confirming the organization's registration with NH Secretary of State;
- Documentation confirming the organization's registration with NH Charitable Trusts Unit;
- A letter of charitable purpose;
- A current "Bingo/Lucky 7 Gaming Operations Participant List";
- A copy of the organization's Bingo and/or L7 house rules;
- A copy of the organization's Bingo program (game schedule); and
- Copies of any contracts or agreements for gaming related services.

Once on file, these documents do not need to be resubmitted with subsequent applications for 2021 game dates. Questions in regards to these topics? Call Irene Rondeau at (603)230-3101.

2021 GAME OPERATOR EMPLOYER LICENSES

This year, 2021 game operator employer (GOE) licenses will be a little different from previous years. We no longer will be issuing a "green" GOE badge for licensees. The GOE license is a license for the entity/business – not a specific individual. In order to correct this, all applicants applying for a GOE license will receive a 8 1/2" by 11" paper license (similar to the facility license) and one complimentary primary game operator license. The complimentary primary game operator license is for the individual that would be the "point of contact" if the commission has any questions that pertain to the entity/business. If a game room would like more than one "point of contact", each additional individual would need to apply for a primary game operator license.

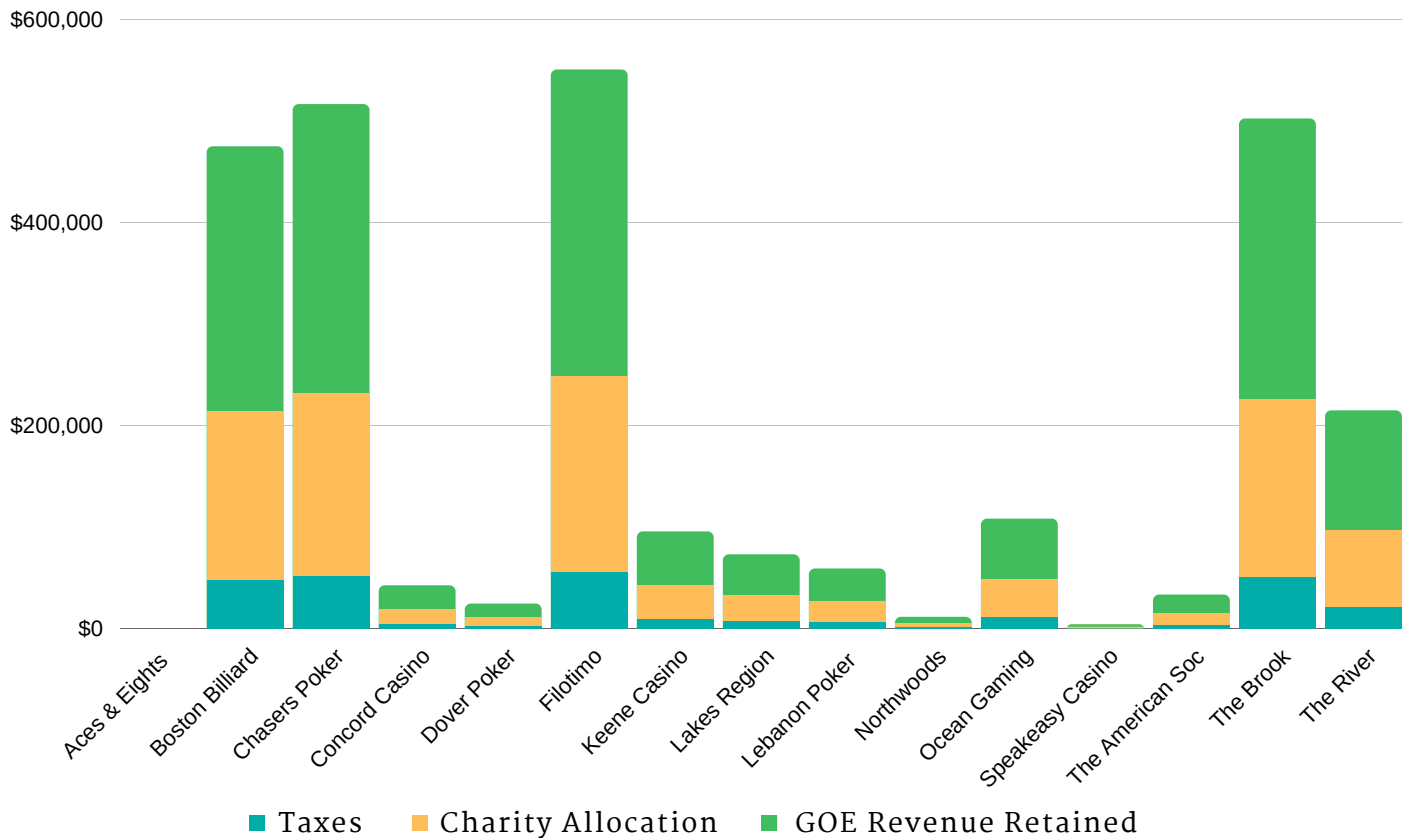
