INSTRUCTIONS FOR SUBMITTING A HOST HALL APPLICATION

A. Supporting Documentation

The following Supporting Documentation must be submitted with the application:

- (1) A network management plan for conducting the shared bingo game that includes details descriptions of the following:
 - a. The technology being used;
 - b. The card inventory control and distribution system;
 - c. The method of calling number at the host hall, and transmitting them to each participating hall;
 - d. The game(s) to be played and the game rule;
 - e. The card sales and reporting;
 - f. The prizes to be awarded;
 - g. Jobs of personnel involved in the conduct and administration of the game;
 - h. The procedure to verify winning cards;
 - i. The financial and inventory control forms that will be used;
 - j. The process for transferring revenue to the network;
 - k. The procedure that will be in place for paying the winner(s);
 - l. The distribution of net profits;
 - m. The network ownership
 - n. The network security; and
 - o. The method for continuation a game in the event of a communication system failure;
- (2) The test results from an independent laboratory that verifies that the software and electronic equipment that will be used to simulcast the shared bingo games:
 - a. Meet the International Technical Standards for Electronic Gaming Machines set forth by the International Association of Gaming Regulators, as required by RSA 287-E:13-a; and
 - b. Otherwise comply with the requirements of RSA 287-E and Pari 1000;
- (3) A copy of any agreements between the host hall and the licensed distributor who will be providing the shared carryover coverall service.
- (4) A copy of all agreements between the host hall and each participating hall, which shall include clearly indicate the cost associated with participating in the shared bingo game.
- (5) A copy of bond posted in the amount of no less than \$50,000 and no more than the highest jackpot prize offered within the previous 24 months payable to the Commission and conditioned upon the licensee's compliance with the rules and laws of the Commission, as established by RSA 287-E.

B. Where and When to Submit the Application

Submit the completed application, and all supporting documents:

Applications must be received at least 30 days, but not more than 60 days prior to the first proposed game date.
