INSTRUCTIONS

A. SUPPORTING MATERIALS

The following supporting materials must be submitted with your application:

- A copy of the written, executed contract between the applicant and at least one stable, or between the applicant and a licensee under RSA 284:15, to sell goods or services at the racing premises where the stable will operate or which is operated by the licensee under RSA 284:15.
- A copy of the written list of the goods or services that the applicant will offer for sale that was provided to the licensee under RSA 284:15 at whose racing premises the vendor will operate.
- A copy of the written statement provided to the licensee under RSA 284:15 relative to the locations on the racing premises where goods or services will be offered for sale.

B. PAYMENT OF LICENSING FEE

Include payment of the \$40 (\$20 for Agricultural Fairs) licensing fee with the application

C. SUBMITTING THE APPLICATION

Submit the completed application, including all required documents and the licensing fee to:

NH Lottery Commission, Racing and Charitable Gaming Division, 14 Integra Drive, Concord, NH 03301

Applications must be received at least 120 days prior to engaging in any activities for which the license is required

D. KEEP ALL INFORMATION UP-TO-DATE

If at any time during the term of a license, the information provided by a licensee on the application, supplemental application, or supporting materials becomes inaccurate, the licensee must, immediately upon the information becoming inaccurate, submit a written correction to the racing secretary and the judge appointed by the Commission, at the racing premises at which the application being corrected was filed.
